 - Full Time Cleaner During The Day
- Cleaning student desks
- Individual Student Supplies

Temperature Checks SCREENING

- Camera that does a thermal scan
- If someone has a temperature over 100, picture is taken, then notification happens
- When a student arrives late to school





Electronic Questionnaire SCREENING

- Computer station
- App on your phone
 1. Have you or a member of your household tested positive for, or had a confirmed case of COVID-19 in the past 14 days?
 2. Are you experiencing any COVID-19 or flu-like symptoms such as (Fever or chills, Cough, Shortness of breath or difficulty breathing, Fatigue, Muscle or body aches, Headache, New loss of taste or smell, Sore throat, Congestion or runny nose, Nausea or vomiting, Diarrhea?)
 3. Are you or any member of your household under active quarantine due to COVID-19 exposure?
 4. Have you been in contact with anyone who has a confirmed case of, or has been exposed to COVID-19?
 5. Have you traveled outside the U.S. or to a state that is restricted, within the past 14 days?

- The School is responsible for reporting and screening.
- The School is **NOT** testing.
- Collaborative Effort – DOH and School
- Testing - your doctor or medical facility.
- Contact Tracing – through the DOH.

Bussing

- Student temperature checks
- Students without a mask will be provided a mask
- Limit seating to 22 students, unless families are sitting together
- Assigned seating
- Release one bus at a time, load one bus at a time
- Start time for students will be 7:35
- No students in the building before 7:35
- We do not have pick up or drop off times yet
- One time bus notes.
- Drivers will be disinfecting their busses



Food Service

- Breakfast in the room
- Students will be eating lunch in the gym
- Six feet apart
- Barriers
- Masks remain on unless seated to eat
- The cafeteria staff will be preparing meals for students that request them during the “remote days” when the hybrid model is followed. These meals will be sent home with students.
- We will establish a central pickup point, during full remote, for students that request meals.
- Students will not be allowed to share food
 - No birthday treats
 - Snacks and water bottles/Bottle Filling Stations



Technology

- Students in grades PreK-2: android tablets
- Students in grades 3-12: chromebooks
- All staff: devices, cameras in classrooms
- Internet: address the equity issue

 - Specials
 - Lockers/Cubbies
- No foreign exchange students
- No afterschool or evening activities
- No outside groups will be allowed to use our facilities
- Traffic at the both buildings
- Fire drills/safety drills
- Student orientation
- No visitors to the building
