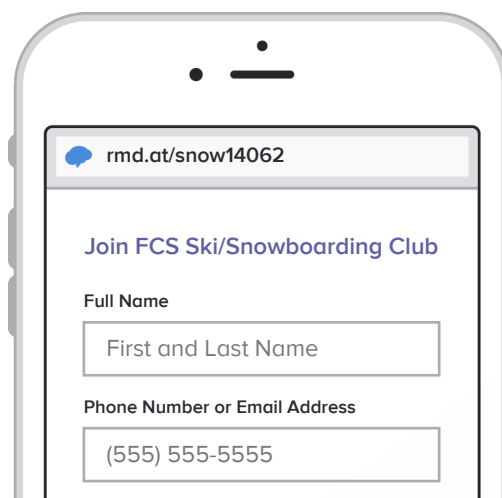

I also understand that the binding release/retention values will be set on the basis of my height, weight, skier classification and age, and I verify the accuracy of all information provided by me or on my behalf in connection with this equipment rental. I understand and am aware that all snow sports, including those which the equipment I am renting apply to, are **HAZARDOUS** and that the use of snow sports equipment involves risk of injury to any and all parts of the user's body. I have read and understand the statements describing the risks inherent in all snow sports, including skiing and snowboarding, as well as the statements concerning the responsibilities of persons using snow sports equipment, which are outlined on the "warnings to skiers" and "skiers responsibility" signs posted throughout the Kissing Bridge snow sports area and I agree to freely and expressly assume each of those risks. I understand that I will be instructed on the use and function of the snow sports equipment. I understand I may ask the rental shop technicians whatever questions I may have about the equipment. I agree not to accept the equipment until all of my questions have been answered to my satisfaction.
