Forestville Central School District Budget

The Forestville Central School District continues to focus on preparing our students for the future. Below is our District's Mission Statement:

The Forestville Central School District is dedicated to educating students to meet or exceed the NYS learning standards, develop their critical thinking skills, and achieve their fullest academic potential. The Board of Education, parents, community members, staff, and faculty are expected to work together to support these educational goals while preparing our students to become independent and responsible members of society. There is a need for accountability at all levels of the organization to improve student achievement and school effectiveness.

Educating students in today's difficult economy continues to be a challenge. Last year, the State of New York provided our District with the same amount of aid as in the previous school year. For the 2010-2011 school year, the Executive Budget Proposal calls for a significant reduction in financial aid. We are faced with what is rapidly becoming an unsustainable funding system for public education as lower revenues coupled with dramatic regulatory increases in expenses have a devastating impact on school programming. The Forestville administration and School Board are aware of the effects that the economy has had on the members of our school community and, as always, continues to try to balance the needs of our students with the wishes of our taxpayers.

The 2010-2011 Forestville Central School District budget is estimated to be \$10,789,265 which is a decrease of \$283,857 over the 2009-2010 school year budget. The percent decrease represents a budget-to-budget reduction of 2.56%. The District administration and Board of Education have made some difficult choices in an effort to reduce expenses while at the same time, deliver a budget that allows us to continue our current level of programming. A portion of the reduction is from reduced debt payments from the previous year. In addition, the District has also lowered expenses such as school supplies and technology purchases. Due to the decrease in school aid and the increased expenses mentioned above, a calculated tax levy of \$3,302,948 is required to finance this budget. This represents an increase of \$94,034 or 2.93% over the 2009-2010 levy.

Under New York State Law, the Board of Education of the Forestville Central School District is required to submit a tentative budget for public inspection fourteen days prior to the budget vote. A public budget hearing will be held on Thursday, May 6 at 6:00 p.m. in the Forestville Central School Elementary Technology Academy to provide the opportunity for you to express your comments to the Board of Education.

All eligible voters will have an opportunity to vote on the budget on Tuesday, May 18, 2010 from 1:00 p.m. to 8:00 p.m. The new location for voting will be in the new rear foyer at the high school. Parking will be available in the new lot.

In addition to this newsletter presentation, a copy of the budget is available for public inspection in the elementary and middle/high school offices as well as the business office located at 12 Water Street, Forestville, New York 14062. A Message from the Board of Education

The Forestville Board of Education would like to take this opportunity to introduce ourselves and discuss some of the board member roles and responsibilities.

The Board of Education is currently comprised of seven members, Carol Woodward, President, Nancy Stock, Vice-President, Sylvester Cleary, Pat Dugan, Bruce Ellis, Mary Kordon, and Adrian Szumigala. Members attend monthly meetings and serve on at least one of the District's committees. The District currently has four standing committees:

- Finance Committee This committee reviews the components of the annual school budget and makes budget recommendations to the Board of Education for adoption. They also meet with the various District auditors and review the financial statements as well as the Five Year Financial Plan, to ensure that District procedures are financially prudent.
- Negotiations Committee This committee negotiates with the various bargaining units and makes recommendations to the BOE when ratifying contracts.
- District Team Meets to discuss the various educational components that the Board and the District set for the year. This includes reviewing curriculum, test scores and academic intervention programs.
- Policy Committee Reviews the District policies and makes recommendations to the BOE for adoption.

To be effective in serving on these various committees, Board Members not only attend monthly meetings but also many training workshops, both during their initial year as a BOE member and throughout their time they serve on the Board. In recent months, FCS Board Members have attended seminars on understanding internal, external audits, and claims audits, as well as conferences on recent court cases that affect public education. In order to receive the most up to date information on the state budget situation, two of us recently traveled to Albany to hear directly from Thomas DiNapoli, our State Comptroller, and our Senate and Assembly members. We also attend trainings offered by both the Chautauqua County School Board Association and the New York State School Board Association to attempt to stay up to date on the newest legal responsibilities of school districts in our ever changing legal climate. We also actively attend as many school functions as possible so we can interact with students, parents, faculty, staff and coaches. Most recently you may have seen many of us at the Music in our Schools concert in the new High School auditorium or at the Grand Opening at the High School.

For the last few months we have been working tirelessly to prepare a responsible budget to bring to our voters. This has been a very difficult task for school districts throughout the state as balancing the program needs for students with the need to present a responsible budget to our taxpayers becomes more difficult due to the fiscal crisis being faced in Albany.

Most importantly however, when our Board sits down to meet, we all agree that the most important thing we do, more important than all the meetings, seminars, etc, is that we work together with our administration and staff to ensure that we offer the best possible programs, from pre-K to grade 12, to meet the needs of our students to prepare them to compete in a 21st century global economy.

We thank you for the opportunity to serve as members of the Forestville School Board and we welcome and encourage your input.





ABSENTEE BALLOT PROCEDURES


Absentee ballots for the Budget Vote/Board Member Election will be available by application to the District Clerk's Office for any qualified voter who will be unable to vote in person due to illness or physical disability, hospitalization, incarceration (unless incarcerated for conviction of a felony), or travel outside the District for employment or business reasons, studies or vacation on the day of the vote/election. Applications for absentee ballots will be available from the District Clerk's Office on or after April 26,2010. Applications must be received by the District Clerk by May 11,2010 to be processed by mail or by 4:00 p.m. on May 17, 2010 in person. Absentee ballots must be received by the District Office, by mail or in person, prior to 5 p.m. on Tuesday, May 18, 2010 to be counted.

SALARY DISCLOSURE REGULATION

Section 111 and 112 of Chapter 274 of the Laws of 1996 amends Section 1608 and 1716 of Education Law requiring a list of the compensation for certain staff. This disclosure regulation includes the Superintendent of Schools whose annual salary is \$121,004.00 with an annualized cost of benefits and other renumeration equaling \$16,139.00 (includes mandatory contributions for Federal Social Security and New York State Teachers' Retirement System with health benefits).

Bus Safety Tips as Spring Arrives

New York State Transportation Facts: The State of New York safely transports students to and from school each year. Every day 2.3 million students are transported on 50,000 safe school buses, operated by 50,000 responsible school bus drivers. These students are transported over 2 billion miles per year. Here at Forestville we safely transport about 600 students to and from school each day. With sports, field trips, and late runs we travel about 220,000 miles per year.

When a stopped school bus flashes its red lights, traffic approaching from either direction, even in front of the school and in school parking lots, must stop before reaching the bus. You should stop at least 20 feet (6 m) away from the bus. You can identify this bus by a "SCHOOL BUS" sign, the red lights on top, and its unique yellow/orange color.

Before a school bus stops to load or unload passengers, the driver will usually flash yellow warning lights. When you see them, slow down and be prepared to stop.

Once stopped for a school bus, you may not drive again until the red lights stop flashing or when the bus driver or a traffic officer waves you on. This law applies on all roadways in New York State. You must stop for a school bus even if it is on the opposite side of a divided highway.

After stopping for a school bus, watch for children along the side of the road. Drive slowly until you have passed them.

Safety Tip: Most school bus-related deaths and injuries occur while children are crossing the street after leaving the bus, not in collisions involving school buses.


