Dear Parent(s)/Guardian(s):

It is a priority of every school district to maintain a safe and healthy learning environment for its students, and clean water is no exception. In 1986, Congress banned the use of lead solder containing greater than 0.2% lead and restricted the lead content of faucets, pipes, and other plumbing materials. Lead is unusual among drinking water contaminants in that it seldom occurs naturally in water supplies like groundwater, rivers, and lakes. New laws that went into effect in 2014 reduced the amount of lead that plumbing fixtures can contain from 8% to 1%. Brass faucets, fittings and valves – including those advertised as “lead free” – may still be a contributing factor to lead levels in drinking water.

Forestville Central School District is in compliance with New York State Public Health Laws requiring all schools and Boards of Cooperative Educational Services (BOCES) to test potable water outlets for lead contamination, to remediate contamination where found, and to notify parents of children and the public of test results.
