To our school community and residents, earlier this year, our financial and administrative team began working on the school budget. The 2020-2021 school budget will be presented to our residents in our school community. Formulating a budget that meets our needs, while remaining fiscally responsible requires detailed decision challenges when we are living in a normal setting. Our district is now challenged to present a budget with so many unknowns of our financial status in the near future. The team is now striving to propose while remaining aware of the changes that may occur. The Board of Education is confident that our team is

proposing a budget that continues to be fiscally responsible, while striving to ensure we educate and prepare our students for their future, as successfully as possible. Be aware that we have continued to raise our test scores and graduation rates which is a reflection of the great work our school team has achieved. Please note that the District's budget vote and Board of Education member election will be held by absentee ballot only. All qualified voters of the District are eligible to vote by absentee ballot. We have two Board of Education member positions for the school board that will be on the ballot. Dave Caccamise and Amy Drozdziel are running for school board. The Budget Vote is June 9, 2020 and the deadline for the District to receive your absentee ballots are that day at 5:00 p.m.

## **Budget Overview**

- · State Aid remains flat at last year's level
- Govenor Cuomo has decided that there will be measurement periods in which state aid may be cut throughout the school year
- We are unsure of the amount of funding we will actually recieve this school year
- To stay within budget and not exceed the tax cap, we have already been forced to make several cuts to our budget in the following areas:
  - · Technology
  - Buildings and Grounds
- Cafeteria
- Business Office
- Transportation
- Instruction
- We are also using reserves and fund balance
- We will be staying below the state imposed tax levy limit which allows our taxpayers to be eligible for the State's proposed tax rebate

A virtual budget hearing will be held on Thursday, May 28, 2020 at 4:00 p.m. to provide the opportunity for you to express your comments to the Board of Education.

#### **Absentee Ballot Vote**

All eligible voters will have an opportunity to vote on the budget by submitting their absentee ballot on Tuesday, June 9, 2020 by 5:00 p.m.

#### **Absentee Ballots**

If you have not received an absentee ballot, please call our District Clerk, Kristin Irwin at (716) 965-6539.

On Friday, May 1, 2020, another executive order was issued, which set the date of school budget votes and board elections for June 9th. In addition, the Executive Order establishes that for the upcoming vote there will be no physical polling sites. Instead, this year's school budget vote will be held entirely through the use of absentee ballots. Forestville Central School District will be mailing an absentee ballot to qualified voters. There will be a self-addressed stamped envelope for you to return your completed ballot to the District Clerk, Kristin Irwin. Absentee ballots must be received by the district clerk by 5:00 p.m. on June 9.

If you are a qualified to vote for the school budget and board elections and you need an absentee ballot, please call our District Clerk, Kristin Irwin at (716) 965-6539.

#### **Voter Qualifications:**

In order to qualify to vote on the District's Budget and Board Members elections you must meet all of the following qualifications:

- Be a U.S. Citizen
- Be 18 years of age or older
- Be a resident of the school district for at least 30 days prior to the budget vote date (Tuesday, June 9)
- Not be prohibited from voting under NYS Education Law

## The 2020-2021 Proposed Budget

Budget and Board of Education Election

## Proposition #1 Budget

The budget proposition would authorize the appropriation of \$12,872,494 to meet estimated school district expenditures for the 2020-2021 school year. This represents an decrease of -2.14% compared to the 2019-2020 adopted budget. Adoption of this budget would result in an anticipated tax levy increase of 1.72%, which is within the limits of the property tax cap as calculated in accordance with Chapter 97 of the Laws of New York and qualifying homes will be eligible for the state's STAR rebate.

#### **Board of Education Election**

Voters will elect two members to the Board of Education. Two at-large vacancies will be filled on the Board of Education by reason of the expiration of the term of office of two incumbents. The candidates receiving the largest number of votes shall be elected to a term to commence on July 1, 2020 and expiring on June 30, 2024.

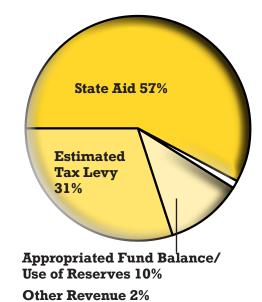

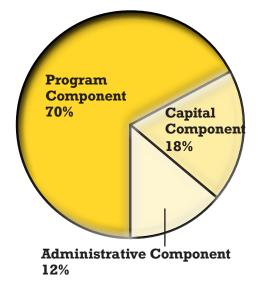
## Administrative Component \$1,732.442
