To Our School Community and Residents, We have been working diligently on the 2021-2022 school budget. Once again we are presenting for vour consideration a very conservative budget. Each year we really take into consideration our community's ability to support our budget. We know that this has been such a tough year for everyone. Not only has it been difficult emotionally, it has been difficult financially. This budget proposal does not include any new positions. We are simply asking for your support to continue our instructional program as it is now.

We are not asking for any major upgrades to our buildings either.

We are just planning on maintaining what we have. We have two open seats with different term limits. David Caccamise has been a tremendous asset to our board is resigning so he can spend more time with his family. This is creating a term that will run from May 19, 2021 to June 30, 2023. We also have an open seat with a term that runs from July 1, 2021 to June 30, 2025. This seat is open because Michelle Merritt's term has expired. We have two individuals running for these two seats: Michelle Merritt (incumbent) and Andrea Spengler. The person with the most votes will serve in the four-year term position. The other person will serve in the term starting on May 19th and ending on June 30, 2023.

Budget-At-A-Glance

Budget Overview

- · Preserves the current level of academic programs, student services and extracurricular activities while supporting curriculum
- · Includes conservative use of reserve funds while maintaining the long-term financial integrity of the District
- · Continue to limit spending on items that are mission critical only, while working to improve efficiencies
- Promotes partnerships with neighboring districts for educational collaborations and shared services
- · In response to an ever increasing need for building improvements to ensure student safety, we have earmarked \$100,000 in the 2021-22 budget to cover capital outlay. We anticipate receiving approximately 86% of these costs back in state building aid the following year.
- · We will be staying at or below the state imposed tax levy limit which allows our taxpayers to be eligible for the State's proposed tax rebate

Public Hearing

A public hearing for the voters of the District on the 2021-2022 budget will be held on Thursday, May 6, 2021 at 5:00 p.m. via Zoom, which voters may access and submit questions by contacting Kristin Irwin, District Clerk at kirwin@forestville.com. The hearing will be virtual unless a Governor's Executive Order does not continue the suspension of the in-person meeting requirement of Open Meetings Law to include May 6, 2021 or the public hearing for the budget, in which case the hearing would be held in person.

Budget Vote

All eligible voters will have an opportunity to vote on the budget on Tuesday, May 18, 2021 from 1:00 p.m. to 8:00 p.m. in the elementary cafeteria. Parking is available in the back parking lot. All voters must wear masks and follow the social distance guidelines.

Voting Information

Voter Registration Reminder

- 1. A citizen of the U.S.
- 2. Eighteen years of age or older and;
- 3. A resident of the Forestville Central School District for a period of 30 days or more preceding the annual vote and election.

Voter Information Voting Process

Your vote will be accepted using an optical scanning voting machine. Please bring photo identification with you when you come to vote on May 18.

Absentee Ballot Procedures

Absentee ballots for the Budget Vote/Board Member Election will be available by application to the District Clerk's Office for any qualified voter who will be unable to vote in person due to illness or physical disability, hospitalization, incarceration (unless incarcerated for conviction of a felony), or travel outside the District for employment or business reasons, studies or vacation on the day of the vote/election.

Applications for absentee ballots will be available from the District Clerk's Office on or after April 19, 2021. Applications must be received by the District Clerk by May 11, 2021 to be processed by mail or by 3:30 p.m. on May 14, 2021 in person. Absentee ballots must be received by the District Office, by mail or in person, prior to 5 p.m. on Tuesday, May 18, 2021 to be counted.

Military Voters

Applications for qualified military voters will be available from the District Clerk's Office. The District Clerk must receive a valid ballot application no later than 5:00 p.m. on April 22, 2021. The voter may designate a preference to receive the application or ballot by mail, facsimile or electronic mail.

The 2021-2022 Proposed Budget

Budget and Board of Education Election

Proposition #1 Budget

The budget proposition would authorize the appropriation of \$13,028,780 to meet estimated school district expenditures for the 2021-2022 school year. This represents an increase of 1.21% compared to the 2020-2021 adopted budget. Adoption of this budget would result in an anticipated tax levy increase of 1.29%, which is within the limits of the property tax cap as calculated in accordance with Chapter 97 of the Laws of New York and qualifying homes will be eligible for the state's STAR rebate.

Proposition #2 Bus Purchase

The bus purchase proposition seeks voter approval to purchase 2 (two) 2022 Blue Bird Vision 65-passenger school buses at an estimated cost of \$123,441.11.

Board of Education Election

Voters will elect two members to the Board of Education. Two at-large vacancies will be filled on the Board of Education by reason of expiration of the term of office of one incumbent and resignation of one incumbent. The candidate receiving the largest number of votes shall be elected to a four-year term to commence on July 1, 2021 and expiring on June 30, 2025. The candidate receiving the second largest number of votes shall serve in the term starting on May 19, 2021 and ending on June 30, 2023.

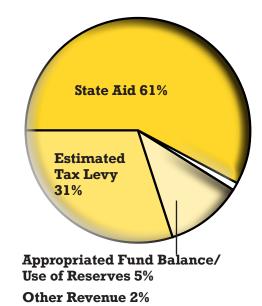

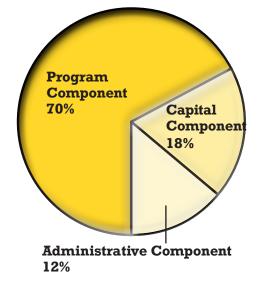
Administrative Component \$1,574,866
