SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. The plan was available for discussion during public comment and with the board of education at all meetings. Administrators were met with regarding available funds and use of those funds in order to better provide the students with the tools necessary to help them achieve a strong education. Those administrators received feedback from teachers and principals along with other school staff. The District engaged a very diverse set of stakeholders through the board of education, public discussion, employees, unions, administrators, and other staff. All stakeholders will continue to be involved throughout implementation and during the grant period through the same methods. Face to face meetings, emails, public meeting. We are a small District that has consulted with our director of special education and teachers of children with disabilities. Teachers and students with low-income are referred to the plan and welcome to discuss any topics during public discussion. Other areas will be discussed as applicable through the grant period.

In the space provided below, please describe the extent to which and how the funds will be used to implement prevention and mitigation strategies that are, to the greatest extent practicable, consistent with the most recent CDC guidance on reopening schools, in order to continuously and safely open and operate schools for in-person learning.

The District plans to use funds as necessary in order to safely reopen and continue to operate schools for in-person learning. Funds are being allocated in order to keep the buses clean, running, and at safely distanced capacity. Funds are also being used to keep classrooms clean and socially distant. Best practices for our building facilities are being adapted and addressed to ensure students can continue to be safely in-person. Desks were replaced that were old and difficult to maintain, while the bathroom was updated to prevent the spread of COVID. Students are using new technology as a learning tool to help develop signs and mitigate the spread of COVID while also sparking interest in possible career opportunities. The District has several other ongoing plans to keep students safely in the classroom while continuing to provide a top tier education.

The District has hired a behavioral specialist to monitor student progress and ensure they all feel comfortable at school. The District will also continue to monitor student academics and testing to ensure that our instruction is still providing a positive experience for the students. Routine check ins and evaluations will be completed with the behavioral specialist to monitor the progress of studens throughout the grant period. The District will also monitor NYS ELA and Math testing scores to evaluate progress.

5. In the space provided below, please describe how the LEA will use the funds it reserves under section 2001(e)(1) - the required reserve of 20% of funds - to address the academic impact of lost instructional time through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year.

The District has reinstated or created several new teaching positions to address the instructional time available for in-person instruction. There are also several new technology purchases being made in order to easily transition instructional time in case of emergency. Adding the teaching positions allows the students longer and easier access to an educator. The technology also provides the students with additional options and more availability to instruction. Meetings and reviews will be scheduled routinely to directly evaluate the impact of lost instructional time with the behavioral specialist. Exam scored on the NYS ELA and Math tests will be reviewed and compared to evaluate the impact of loss instructional time as well. With the increase in teachers and technology the District hopes to limit the impact of loss instructional time and will use the funds to address that.

- Elementary Teacher- to address and reduce class sizes resulting in students having more access to educators and ensuring they receive an
 appropriate level of instruction
- Behavioral Specialist-to address and reduce class sizes resulting in students having more access to educators and ensuring they receive an appropriate level of instruction
- SPED Teacher-to address and reduce class sizes resulting in students having more access to educators and ensuring they receive an appropriate level of instruction
- Technology-to increase access to remote and in person instruction. The increase in technology requirement to ensure all students have access to and do not lose time with our educators is the biggest priority.

The District will use remaining funds to continue to operate and facilitate a safe and comfortable environment for instruction. Sanitizer, masks, additional cleaning hours and staff as necessary, transportation hours and supplies, technology, and other items. The District needed a school resource officer in order to increase coordination with local enforcement agencies and be prepared in case of emergency. This will be monitored yearly and we anticipate the outcome having a positive impact on student safety and response times. Cutting down the school serving line and increasing aides ensure students are following the guidelines while maintaining proper social distancing to prevent and mitigate the spread of COVID-19. Technology will help ensure the school is a safe environment and prevent the spread of COVID from the outside public while also making sure instruction time is not lost due to remote learning. An additional cleaning position will help the District maintain sanitation levels to prevent and mitigate the spread of COVID-19. Minor remodel to help efficiency and reduce COVID transmission. COVID transmission and contract will be monitored vigorously for the unforseeable future and the planned outcome of the use of funds is to decrease these rates and maximize in person instruction.

- Sanitizer, Masks, Cleaning Hours and Staff- to ensure the school is a safe environment and prevent COVID-19 in the district as much as possible.

 This will cause less disruption to education and maximize the in person instruction time.
- Technology- Increasing access for all students to educators. Also to assist educators in providing the most efficient curriculum as possible to the student population.
- Desks- Replacing old desks that could not be maintained and cleaned appropriately. This will prevent and mitigate the spread of COVID 19 while also maximizing time in person instruction while also making the learning environment a better place for students.
- Door Control Systems- To ensure students and staff are the only people present within the District. This will allow easier contact tracing and mitigate COVID-19 from entering the District. In addition this will also reduce COVID-19 transmission and allow for highly congested areas to flow freely with less contact.

The District will utilize the behavioral specialist position to help address social, emotional, and mental health of all students. In addition, the District plans to contract with a School Resource Officer to help students feel like the school is a safe environment. Students disproportionately impacted will be evaluated and closely monitored by their teachers, school psychologist, and the special education department. These students will also be offered additional technology and instruction time provided by the funding. The District specifically targets low-income families and children with disabilities using their psychology and special education department. Being a very small rural District, we do not have large amounts of students in other subgroups.
